He appreciated the efforts for conducting Executive Council meeting via Video conferencing and shared his views on agriculture activity affects due to bumper rabi crop & good monsoon. It helps in generating good business to all the manufactures also required more financial support to farmers from government to buy implements.

Mr. Sarbjeet Singh Panesar Secretary AMMA-India Shared information about the total strength of the association (687) members, having them from all agricultural sectors i.e. implements, tractor, component, gardening tool & power tiller and processing equipment. He also shared the information related to CRM (Crop Residue

Management) scheme for the year 2020-21 in Punjab, Haryana & Uttar Pradesh & empathizes on the centralized approval for bank guarantee, empanelment of manufacturers, testing reports etc. Also discuss on the rate revision in CRM scheme.



Mr. Raj kumar, Chairman Tamil Nadu Chapter shared important information viz. implementation of critical specification of implement be postponed to April 2021; In case of re-testing of same implements GOI should consider minimizing test hours & testing charges; Shared acceptance of 5 Ton trailor subsidy by Joint Secretary

(M&T); introduction of One Nation One Approval Policy for Subsidy; Testing date to be extended till March 2021.



Mr. Bharat Patil, Chairman Maharastra State Chapter shared the information viz. not sufficent funds for subsidy purpose; empanelment & subsidy allocation still pending from state government side.

Mr. Sushil Agrawal, Chairman Uttar Pradesh Chapter shared the information viz. subsidy funds to be released on time so that manufacturer should get sufficent time to manufacture implements; rate revision for SRM scheme implements. Due to COVID 19 effect the prices of raw material and manpower has increased that results in price increase of machine.

Mr. Chintan Patel, Chairman Gujarat Chapter shared the information viz. single policy for subsidy rate approval; funds to be released on time.

Mr. Adwinder Singh, Secretary Punjab State chapter shared information viz. timely approval of subsidy schemes; Increase in testing centres; Centralized empanelment and Bank guarantee scheme.


Mr. Manoj Sharma, Chairman Delhi Chapter shared information viz. funds are not utilities & need to find other alternative to use them.

ICAR-CIAE, Bhopal organized a Web based Workshop on "Impact of COVID-19 on Agricultural Machinery Manufacturing Sector in India: Present Challenges and Future Strategies on 10<sup>th</sup> July 2020 from 10:30 AM onwards. The aim of this program was to discuss the present challenges faced by the tractors, power tillers and farm machinery manufacturers from different parts of the country due to COVID-19 pandemic and to formulate strategies to sustain the mechanization goals of the country. About manufacturers of tractors agricultural implements from various parts of the country participated in the meeting.



Power point presentations were made by association members such as Mr. S V Raju,

Chairman; Mr. Mitul Panchal, Sr. Vice Chairman; Mr. Rajkumar Arumugam, Vice Chairman and Mr. Sarbjeet Singh Panesar, Secretary.



Following points were raised and discussed:

- 1. Agricultural Machinery and its supply chain under essential commodity
- Postponement of New Bharat Stage IV Emission norms
- 3. Export related issues
- Rectification of Vahaan Portal enabling registration of tractors and combined harvesters
- 5. Decision on subsidy to have one price across the nation
- Considering agriculture machinery as input to agriculture just like seeds, fertilizer and chemicals so that farmers

- can use Kisan Card to buy agricultural machinery excluding tractors, power tillers and combine harvester.
- Implementation of critical specification of implement should be postponed to March 2021.
- 8. In case of re-testing of same implements GOI should consider minimizing test hours & testing charges.
- Centralized approval of testing report & bank guarantee by GOI.
- To provide modernization funds for agricultural machinery industries at least once in 15 years to upgrade manufacturing facilities.
- 11. Shortage of migrant labour for paddy transplanting and other farm operations.
- 12. In recent years, many states have started imposing huge EMD and Security deposits for the empanelment of Firms and their products for the various SMAM schemes and these amounts varies from state to state with very high value. Hence, we request that the empanelment of the firms to be taken up at National level with one

- EMD/Security deposit to cover for all the states.
- 13. Testing and certification for the financial year 2020-21:
  - Due to corona pandemic outbreak and the following lockdown, the product testing and certification has become impossible. Considering the same, the ministry has extended the validity of the existing certificates till 31<sup>st</sup> December 2020. But, due to the continued lockdown measures of many states and the interstate travel ban etc.., the testing has not been started by many testing centres as well as by the Industries. Hence, we hereby request to further extend the validity of the test reports to 31<sup>st</sup> March 2022.
- 14. Establish Agri Machinery Technology Upgradation Fund (TUF) – To improve and implement modern manufacturing technology and Industry 4.0 kind of manufacturing methods which will make the industry to stand up against others in global market.



## Orientation on new online application of software being developed by NIC for FMTTIs

Ministry of Agriculture & Farmers Welfare, Department of Agriculture, Cooperation & **Farmers** Mechanization Welfare, Technology Division has organized a meeting through video conferencing for the orientation on new online application software being developed by NIC for FMTTIs on 25<sup>th</sup>August 2020 at 2.00 P.M. NIC officers made the presentation on application software. Directors, NIC Officers and all the executive members of the various associations viz TMA, PTMA, AMMA-India, AICMA, etc attended the meeting.

Farm machines and equipment play a pivotal role in crop production, and its handling, transportation, processing and preservation. For promoting the use of machines, the Government established the "Agricultural Machinery Utilization Training Centre". The objective of establishing the Centres was to train the prospective farmers on proper use, maintenance and up-keep of farm machines. With the growth of indigenous production of tractors and farm equipment, the Institutes have developed the necessary expertise and infrastructure and has attained International

Standards in the field of farm machinery training and testing and is well recognized amongst leading testing organizations in the world. With a view to enhance the pace agricultural mechanization. Government has laid emphasis to provide financial assistance to the farmers and other target groups for purchase of different kinds of farm equipment, demonstration of new equipment among farmers for spread new technology, human resource development in operation, maintenance/ repairs and management of agricultural machinery and the quality improvement through testing and evaluation besides institutional credit & fiscal measures. The Machinery Training & Testing Institutes at Budni (M.P.), Hissar (Haryana), Garladinne (A.P.) and Bishwanath Chariali (Assam) established by the Government of India have playing a vital role in promoting agricultural mechanization. The Department has developed a software for the online submission of agricultural machinery for testing at four institutes mentioned above. There was demonstration of software by NIC. Farm machinery testing processes followed are:



- Registration of manufacturer on portal
- 2. Submission of online application
- 3. Scrutiny and approval of application
- 4. Fee submission
- 5. Random sampling of machinery

- 6. Arrival and testing of machinery
- 7. Generation of DTR
- 8. Generation of FTR


